## PWR-BRU Impulse Launch Promotion

## **Full Terms and Conditions**

Please read these terms and conditions carefully. By submitting an entry to this promotion, you are deemed to have read and accepted them.

**Promoter:** A.G. BARR p.l.c., Westfield House, 4 Mollins Road, Cumbernauld, G68 9HD (us, we, our).

**Promotional Period:** Opens at 00:00 on 4 September 2023 and closes at 23:59 on 31 January 2024.

**To enter**: To enter you must: (i) scan the QR code printed on the flyer sent to you by the Promoter and complete the online registration form for your store (the "**Participation Form**") by 23:59, 30 November 2023, and (ii) have a point of sale (POS) visible in your store and set up facings of PWR-BRU/RAW Energy product in accordance with one of the following tiers:

- (1) have 4 facings of PWR-BRU/RAW visible in store and have participating POS sited (Tier 1);
- (2) have 8 facings of PWR-BRU/RAW visible in store and have participating POS sited (Tier 2); and
- (3) have 12 facings of PWR-BRU/RAW visible in store and have participating POS sited (Tier 3).

After that, one of the following will happen:

(1) An AG Barr field representative will visit your store at some point in between beginning of the promotion and the end of October to confirm the number of PWR-BRU/RAW Energy product facings in store and visibility of the participating POS. This initial visit will be followed up with a visit in January 2024 to confirm the facings are still on display throughout the duration of the promotion. The dates for a visit will be chosen by the Promoter at its sole discretion and Promoter is under no obligation to provide any prior notice of a visit to a participant.

OR

(2) Alternatively, if AG Barr field representative is unable to visit your store or if you entered promotion after the end of October 2023, A.G. Barr will send you additional leaflet with QR code and instructions on how to enter the Prize draw. You will need to scan QR code, complete the form and upload photo(s) of number of PWR-BRU/RAW Energy product facings in store. This initial photo submission will be followed by an additional photo submission request sent to you by email in January.

The completion of the Participation Form constitutes an entry into the promotion. Achieving requirements of one of the Tiers constitutes entry into the Prize draw as described below.

**Eligibility**: Promotion open to GB residents only, aged 16+ who are our direct trade customers. This trade promotion is not open to consumers for entry. No purchase necessary. Normal exclusions apply. A mobile phone/tablet with QR scanning and photo camera capability, and internet access, required to enter. Entries made through agents/third parties, bulk entries or automated entries are invalid. Any promotion entries received before the promotional period or after 23:59, 30 November 2023 will not be valid and will not be entered into this promotion. Maximum one entry per trade customer's store during this promotion.

**Prizes:** Participants that achieve one of the Tiers will get the following:

- (1) Tier 1 will be awarded 1x free case of 500ml IRN-BRU Xtra **and** will be granted 1 x entry into the prize draw to win £1000 ("**Draw Entry**");
- (2) Tier 2 will be awarded 2x free case of 500ml IRN-BRU Xtra **and** will be granted 2 x Draw Entries; or
- (3) Tier 3 will be awarded 3x free case of 500ml IRN-BRU Xtra <u>and</u> will be granted 3 x Draw Entries.

In these terms, each case of 500ml IRN-BRU Xtra is referred to as "**Reward**" and the £1000 winning as the "**Prize**".
