Please read these terms and conditions carefully. By submitting an entry to this Promotion, you are deemed to have read and accepted them. The Promoter may require you to provide proof that you are eligible to participate in the Promotion.

Promotional Period: Opens at 00:01 on 3 August 2023 and closes at 00:01 on 15 August 2023.

How to enter: This is an online promotion and internet access and a TikTok account is required.
